Must demonstrate need, usually by presenting Medicaid card, Bridge card or acquiring referral through 211. Also helps individuals who have a barrier for employment (e.g., medical scrubs, steel-toed boots, etc.); referral comes from employer.

[≠] Food distribution once per month on 4th Saturday from 9:00 a.m. - 11:00 a.m.

[>] Must demonstrate emergency need as well as ID for every member of the family, including minors. By appointment only.

[>] For active duty/veterans and their households only (except dishonorably discharged and/or court marshalled). Must verify homelessness and meet low income requirements.
